

Federal Performance Indicator 2 – Services Provided in Natural Environments

“Services Provided in Natural Environments” is defined as IFSP services provided within typical locations and activities that a same aged child without a disability participates in such as the home, childcare, Early Head Start, or community locations such as parks or children’s libraries or other places the child and family go.

Data is based on APR Data submitted February 1, 2025, for the full fiscal year (July 1, 2023-June 30, 2024).

The State Target (goal) is set with input from the Arkansas Interagency Coordinating Council (AICC) and with input from EI Providers and other stakeholders. The State Target must increase annually.
